


A Message from the Superintendent




This millage renewal does <u>NOT</u> cost homeowners one penny in taxes and would ONLY be paid by rental property owners, owners of second homes, commercial properties and businesses. It has no impact on a resident's primary home. This renewal can only be used to support our general operations so we can continue to receive full state funding to help our students succeed.

The Chippewa Valley Schools Operating Millage Renewal benefits our students, our families and our entire community by:

- Helping us continue providing real-world, hands-on learning opportunities that prepare our students for the jobs of today and tomorrow, helping create a talent pipeline right here in Macomb County.
- Supporting critical safety upgrades to help keep our school community safe.
- Helping to keep our property values high and home values strong, making our community an amazing place to live, work, raise a family or start a small business.

Operating Millage Renewal Proposal

This proposal would renew and restore the authority of the School District to continue to levy the statutory limit of 18 mills on all property, except principal residences (owner occupied homes) and other property exempt by law, for general operating purposes, which currently expires with the School District's 2024 tax levy and allow the School District to continue to levy the statutory limit of 18 mills in the event of future Headlee rollbacks of up to 1 mill. This authorization will allow the School District to continue to receive revenues at the full per pupil foundation allowance permitted by the State.

Shall the limitation on the total amount of taxes which may be assessed against all property, except principal residences and other property exempted by law, situated within the Chippewa Valley Schools, County of Macomb, Michigan, be increased in the amount of 19 mills with 18 mills being the maximum allowable annual levy (\$18.00 on each \$1,000 of taxable valuation), for a period of ten (10) years, 2025 to 2034, inclusive? This operating millage if approved and levied, would provide estimated revenues to the School District of \$16,500,000 during the 2025 calendar year, to be used for general operating purposes.

Millage renewal to appear on Aug. 6 ballot

On Tuesday, Aug. 6, voters will have the opportunity to vote on the Chippewa Valley Schools Operating Millage Renewal. This important millage renewal would:

- <u>NOT cost homeowners one penny in taxes.</u> It would only be paid by rental property owners, owners of second homes, commercial properties and businesses to continue receiving full state funding for school operations.
- Allow us to support career-technical instructors, teachers and support staff to help prepare students for in-demand, good-paying jobs, including in the skilled trades.
- Allow us to support school safety officers, school counselors, social workers, health services staff and food service workers essential to student health and success. If passed, all funds from this millage renewal will be required to undergo an annual independent audit and be publicly disclosed on the district's website.

How to vote

- WHO: All Chippewa Valley Schools district voters
- WHEN: Tuesday, Aug. 6. Polls open from 7 a.m. to 8 p.m.
- **HOW:** Registered voters can cast a ballot at their established polling location. Voters also have the opportunity to vote absentee.

Chippewa Valley Schools Operating Millage Renewal





Q: What is the Chippewa Valley Schools Operating Millage Renewal?

A: The Chippewa Valley Schools Operating Millage Renewal supports Career and Technical Education instructors, teachers, support staff, school safety officers, school counselors and social workers who help prepare our students for success and careers.

Q: When will this millage renewal appear on the ballot?

A: This millage renewal will appear on the Tuesday, Aug. 6, 2024 ballot.

Q: Will this millage renewal raise my taxes?

A: No. This millage renewal <u>does not cost homeowners one penny in taxes</u>, and is <u>only</u> paid by rental property owners, owners of second homes, commercial properties and businesses.

Q: What will the funding be used for?

A: Funding from this millage renewal will be used to support career-technical instructors, teachers, support staff, school safety officers, school counselors, social workers, school health services staff and food service workers essential to student safety, student health and student achievement.

Q: Does this millage renewal pay for new buildings or construction?

A: No. By law, the millage renewal only supports the district's general operations and cannot be used for any new construction.

Q: Why do we need this millage renewal now?

A: This is a renewal of an existing millage that supports the district's general operations to continue receiving full state funding and help students succeed. This is not a new millage. It must be approved every 10 years and was last approved by voters in 2014.

Q: What happens if this millage renewal doesn't pass?

A: Chippewa Valley will lose approximately \$16 million annually if this millage renewal is not approved by voters. Without the funds gathered from this millage renewal, the district could be forced to cut important student programs and staff, including school counselors, psychologists, school health services staff and more.

Q: How much will this millage renewal cost?

A: The Chippewa Valley Schools Operating Millage Renewal would continue the current, 18-mill tax levy <u>only</u> paid by rental property owners, owners of second homes, commercial properties and businesses for the next 10 years. This millage renewal is <u>NOT</u> paid by homeowners and does not cost homeowners one penny in taxes.

Q: How do we know funding from the millage renewal will be spent wisely?

A: Chippewa Valley Schools has a proven track record of fiscal responsibility, transparency and accountability, and all funds from this millage renewal will be required to undergo an annual independent audit and be detailed on the district's website.

Q: How does this millage renewal help prepare students for the modern workforce?

A: This millage renewal supports hands-on learning opportunities that prepare students for the jobs of today and tomorrow, whether that means college, technical training or entering the workforce right after graduation.



Madison Galich is a remarkable and dedicated student with a passion for math and science. In addition to her individual achievements, Madison's leadership qualities shined through with her classmates. She became


