Titles Deselected Per District Guidelines

Material selection is an ongoing process that includes the removal of materials that no longer meet the selection criteria and the replacement of lost and worn materials still of educational value. Materials no longer factually accurate or useful, works that no longer support the curriculum, works in little demand, and books in poor condition that do not warrant reordering will be removed to make space for new titles. The process of deselection (weeding) is an integral part of assessing the collection. This keeps collections relevant, accurate, and useful and it facilitates more effective use of space in the media center.
